INTRODUCTION OF GENERAL ORDINANCES

By City Controller:

GENERAL ORDINANCE No. 39, 1934.

AN ORDINANCE transferring moneys from certain funds and re-appropriating the same to other designated funds, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE
CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Seven Hundred Fifty Dollars (\$750.00) now in Street Commissioners Gasoline Tax-Paved Streets Fund No. 33, Gasoline, Oil, Tires, Tubes, etc., be and the same is now hereby transferred therefrom and reappropriated to Street Commissioners Gasoline Tax—Paved Streets Fund No. 72, Equipment.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the mayor and publication according to law.

Which was read a first time and referred to the Committee on Finance.
