APPROPRIATION ORDINANCE NO. 6, 1936

AN ORDINANCE appropriating Three Thousand Dollars (\$3,000) from the anticipated unexpended and unappropriated balance in the Department of Public Health and Charities General Fund for the year 1936, to the division of Administration-Board of Health—in said department, for the payment of two (2) barber shop inspectors, which positions were heretofore created by General Ordinance No. 68, 1935, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That there be and there is hereby appropriated from the anticipated unexpended and unappropriated balance of the Department of Public Health and Charities general fund for the year 1936, the sum of Three Thousand Dollars (\$3,000) to said department, Division of Administration—Board of Health, Fund 11—Salaries and Wages, regular, two (2) Barber Shop Inspectors at \$1,500.00 each—\$3,000.00, which sum is for the payment of the salaries of two (2) barber shop inspectors at the rate of Fifteen Hundred Dollars (\$1,500) each per year, which positions of barber shop inspectors were heretofore created by the provisions of General Ordinance No. 68, 1935.

Section 1. That for the purpose of providing the owners or occupants of certain premises fronting on certain public streets of the City of Indianapolis with ingress and egress for passengers, materials and merchandise coming to or going from such premises, such

owners or occupants having complied with the provisions of Section 26 of General Ordinance No. 96, 1928, as amended by General Ordinance No. 31, 1931, as amended by General Ordinance No. 58, 1931, relative to the establishment of passenger and/or loading zones, and said board having caused an investigation to be made thereof and having recommended the establishment, pursuant to the terms of the aforesaid ordinances, the following passenger and/or loading zones be and the same are hereby established, to-wit:

18 feet in front of 221 North Pennsylvania Street, said premises being occupied by the Akron Surgical House, Inc.

An additional 18 feet in front of the Hume-Mansur Building, at 23 East Ohio Street.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the mayor and publication according to law.

GENERAL ORDINANCE NO. 17, 1936

AN ORDINANCE approving an order of the board of public safety of the City of Indianapolis designating a taxicab stand location in said city, and fixing a time when the same shall take effect.

WHEREAS, The board of public safety of the City of Indianapolis has adopted an order designating a taxicab stand, in conformance to Section 17 of General Ordinance No. 28, 1931 (as amended), as amended by Section 2 of General Ordinance No. 96, 1933 (as amended), and has submitted the same for approval to the common council; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the order of the board of public safety of the City of Indianapolis, dated October 1, 1935, designating the following taxical stand location in said city be and it is in all things ratified, to-wit:

A three (3) car taxicab stand in front of 1033 Prospect Street, on the scuth side of the street, starting at the west property line of 1033 Prospect Street and extending east for a distance of forty-eight (48) feet.

Section 2. This ordinance is supplemental to General Ordinance No. 8, 1929, and shall take effect from and after its passage and approval by the mayor.

GENERAL ORDINANCE NO. 18, 1936

AN ORDINANCE to amend Section 1 of a General Ordinance No. 68, 1935, as amended, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Seltion 1. Be it enacted by the Common Council of the City of Indianapolis, that Section 1, of the above entitled ordinance be amended to read as follows: "That for the purposes of this ordinance a barber shop, barber school, barber college, or the business of barbbering shall be construed to mean, any place or establishment where any one or any combination of the following practices, when performed upon the head, face and neck for cosmetic purposes and done for the public generally for pay, either directly or indirectly, are engaged in:

Shaving or trimming the beard,

Cutting hair,

Giving facial and scalp massage or application of oils, creams, lotions or other preparations, either by hand or mechanical appliances,

Singeing, shampooing or dyeing the hair or applying hair tonic,

Applying cosmetic preparations, antiseptics, powders, oils, clays or lotions to scalp, face or neck.

Provided, however, that such practices when done for the treatment

of physical or mental ailments or disease shall not constitute barbering. Provided further that nothing in this ordinance shall be construed to include beauty shope, beauty culture colleges, beauty culture schools, registered beauticians, hair dressers, manicurists or electrolcgists.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the mayor and publication according to law.
