INTRODUCTION OF GENERAL ORDINANCES

By the Board of Safety:

GENERAL ORDINANCE NO. 22, 1936

AN ORDINANCE requiring keeping of records and the making of reports to the Division of Accident Prevention of the Indianapolis Police Department, of automobiles received or accepted for repairs, providing a penalty for violation, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. Any person, firm or corporation, who shall, directly or through any agent, officer or employee, receive or accept any automobile for repairs thereon, shall, at the time of such receipt or acceptance, make a written record relating to the same, legibly written in ink in the English language, showing an accurate account of the date and time when said automobile was so received or accepted for re-

pairs; the broken, damaged, dented, wrecked, weakened or impaired condition of said automobile and/or any part thereof at said time; the nature and extent of the repairs to be made on such automobile; the motor number and body number thereof appearing thereon; any other serial numbers appearing thereon; the seating capacity, color, style of body, name of, and the state license number appearing on any license tags or plates attached to any such automobile. Said record shall also state the name and residence given by the person from whom said automobile was received or accepted for repair; a description of the color, sex, complexion, style of beard and style of dress of the person from whom said automobile was received or accepted for repair, together with an estimate of the age, height and weight of such person; the name of the person to be charged for repairs thereon. The written records herein provided for shall be kept and preserved by the persons herein required to make the same for a period of one (1) year from the date thereof, and shall at all reasonable times be open to inspection by the Chief of Police of said city, or any member of the police force authorized by the Chief of Police to examine the same.

Section 2. Any person, firm or corporation who shall directly or through any agent, officer or employee, receive or accept any automobile for repairs thereon, shall, by noon of the following day of such receipt or acceptances, make and deliver a report relating to the same to the Division of Accident Prevention of the Indianapolis Police Department on one side of a blank white paper form to be furnished and provided therefor by the aforesaid division of the aforesaid Police Department of the City of Indianapolis, giving an accurate account of the date and time when said automobile was so received or accepted for repairs; the broken, damaged, dented, wrecked, weakened, or impaired condition of said automobile and/or any part thereof as of, and at, the time said automobile was so received or accepted for repairs; the nature and extent of the repairs to be made on such automobile; the motor number and body number thereof appearing thereon; and any other serial numbers appearing thereon; the seating capacity, color, style of body, the name of, and the state license number appearing on any license tags or plates attached to, any such automobile. Said report shall also state the name and residence given by the person from whom said automobile was received or accepted for repair; a description of the color, sex, complexion, style of beard and style of dress of the person from whom said automobile was received or accepted for repair, together with an estimate of the age, height and weight of such person; the name of the person to be charged for the repairs thereon. The Chief of Police shall keep on hand at all times a sufficient supply of the blank forms of reports for the convenience of those herein required to report, and said Chief of Police shall, upon request, without charge furnish such persons with a sufficient supply of said forms in advance of their immediate requirements for the purpose of enabling such persons to make said reports.

Section 3. None of the provisions of this ordinance shall apply to persons making repairs upon cars owned by them.

Section 4. Whoever shall violate any of the provisions of this ordinance shall, upon conviction thereof, be fined in any sum not exceeding two hundred dollars (\$200.00), to which may be added imprisonment not exceeding ninety (90) days.

Section 5. This ordinance shall be in full force and effect from and after its passage, approval by the mayor and publication according to law.

GENERAL ORDINANCE NO. 23, 1936

- AN ORDINANCE authorizing the City of Indianapolis, Indiana, to make a temporary loan in the sum of One Hundred Twenty-five Thousand Dollars (\$125,000.60) for the use of the Board of Health of said city in anticipation of and payable out of the current revenues of said Board of Health collectible in the year 1936 for general Board of Health purposes; authorizing the legal rate of interest to be charged therefor; providing for legal notice, and fixing a time when the same shall take effect.
- WHEREAS, the Board of Health of the City of Indianapolis, Indiana, on the 21st day of February, 1936, adopted the following resolution spread of record and made a part of the proceedings of said board, to-wit:

EOARD OF HEALTH RESOLUTION NO. 1, 1936

WHEREAS, the Board of Health of the City of Indianapolis, Indiana, from the 16th day of March, 1936, to the 15th day of May, 1936, will be without sufficient funds with which to meet its pay-roll and current expenses necessary for the proper carrying on of the functions of said board and payable out of the general fund of said Board of Health; and

- WHEREAS, the said pay-roll and other necessary current expenses for said period payable as aforesaid will amount to approximately \$125,000.00; and
- WHEREAS, the first semi-annual installment of taxes levied by the City of Indianapolis for general Board of Health purposes for the year 1936, collectible on or before May 5, 1936, will amount to more than \$126,232.88;
- NOW, THEREFORE, BE IT RESOLVED by the Board of Health of the City of Indianapolis, Indiana, that an ordinance be prepared and presented to the city controller and to the common council of said city for passage, providing for the making of a temporary loan by said city for the total principal sum of \$125,000.00 for the use of the Board of Health for the aforesaid purpose at a rate of interest not to exceed six per cent (6%) per annum and for a period not to exceed sixty (60) days, said temporary loan, or loans, to be made in anticipation of the current revenue of said Board of Health collectible in the year 1936, for general Board of Health purposes. Such loan shall bear interest only from the date the same is available for the use of the Board of Health; and
- BE IT FURTHER RESOLVED by said Board of Health that there be and is hereby appropriated out of the current revenues of the said Board of Health for the year 1936, levied and collectible for said general Board of Health purposes, for the purpose of repaying said temporary loan with interest thereon as the same becomes due, the sum of \$126,232.88, or so much of said sum as may be necessary therefor. NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the City Controller of the City of Indianapolis be, and he is hereby authorized and empowered to negotiate a temporary loan for the use of the Board of Health of said City of Indianapolis, Indiana, in anticipation of current revenues of said Board of Health for the year 1936, levied for general Board of Health purposes, actually levied and now in the course of collection. Said loan shall not exceed the sum of \$125,600.00, payable out of the current revenues of said Board of Health, at a rate of interest not to exceed six per cent (6%) per annum, for a period not to exceed the period set out in this ordinance. Said loan shall be let to lowest and best bidder, or bidders, at competitive bidding on the annual rate of interest under conditions prescribed in the notice of sale, which notice shall be published for at least one day in at least one daily newspaper

of general circulation, published in said City of Indianapolis, Indiana. The mayor and city centreller of said city are hereby authorized and directed to execute the proper obligations of said City of Indianapolis, Indiana, for the amount of said loan, which obligation, or obligations, shall also be countersigned by the president of the Board of Health of said city. To the payment of such obligations the faith of the City of Indianapolis, Indiana, is hereby irrevocably pledged.

Section 2. Said temporary loan shall be made by borrowing the sum of \$125,000.00 for a period of sixty (60) days, beginning with March 20, 1936, and ending with May 19, 1936. Said loan shall mature in full and be made payable May 19, 1936, and shall bear interest only from the time the same is made available for use of the Board of Health.

Section 3. The sum of \$125,000.00 of the general fund of the Board of Health is hereby set apart and appropriated to Board of Health Fund No. 63, hereby created, for the repayment of the principal of said temporary loan; and the sum of \$1,232.88 of said general fund of said Board of Health is hereby set apart and appropriated to Board of Health Fund No. 61 for the payment of interest on said temporary loan.

Section 4. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.

AN ORDINANCE to amend General Ordinance No. 114, 1922, commonly known as the Zoning Ordinance, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the U3 or business district, the A3 or 2,400 square foot area district and the H1 or 50 foot height district be and the same are hereby amended, supplemented and extended so as to include the following described territory:

Beginning at a point on the east property line of Gent Avenue 80 feet north of the north property line of West 16th Sreet;

thence east and 80 feet north of and parallel to, the north property line of West 16th Street to a point on the west bank of Fall Creek; thence south with the meanderings of the west bank of Fall Creek to a point 80 feet south of the south property line of West 16th Street; thence west and 80 feet south of and parallel to, the south property line of West 16th Street to the east property line of Gent Avenue; thence north on the east property line of Gent Avenue a distance of 250 feet to the point or place of beginning.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the mayor and publication according to law.

Which was read the first time and referred to the Committee on Law and Judiciary.

By the Board of Works and Sanitation:

GENERAL ORDINANCE NO. 25, 1936

- AN ORDINANCE authorizing the Board of Public Works and Sanitation, through its duly authorized purchasing agent to purchase, in conjunction with the Works Progress Administration of the United States Government, certain corrugated iron pipe and to expend therefor a sum not exceeding Eleven Thousand Two Hundred Dollars (\$11,200), and fixing a time when the same shall take effect.
- WHEREAS, the purchase of six hundred twenty (620) feet of corrugated iron pipe approximately fourteen (14) feet in diameter is contemplated by the Board of Public Works and Sanitation and the Works Progress Administration of the United States Government for use in the Pogue's Run sewer; and
- WHEREAS, the total estimated cost of said corrugated pipe is Twenty-eight Thousand Dollars (\$28,000); and
- WHEREAS, the said Works Progress Administration proposes to contribute and pay three-fifths (3/5) of the total cost of said corrugated pipe in conjunction with the contribution and payment by the Board of Public Works and Sanitation of two-fifths (2/5) of said total cost of said pipe; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Beard of Public Works and Sanitation of the City of Indianapolis, through its duly authorized purchasing agent, is hereby authorized to contribute and expend in the purchase of six hundred twenty (620) feet of corrugated iron pipe, approximately fourteen (14) feet in diameter, a sum of money equivalent to two-fifths (2/5) of the total cost thereof, said sum so to be contributed and expended not to exceed the sum of Eleven Thousand Two Hundred Dollars (\$11,\$00), and said sum to be conjoined with a sum of money equivalent to three-fifths (3/5) of said total cost of said pipe contributed and expended by the Works Progress Administration of the United States Government in said purchase of said pipe.

Section 2. That said sum of Eleven Thousand Two Hundred Dollars (\$11,200) to be used and expended by said Board of Public Works and Sanitation in the purchase of said corrugated pipe as in the manner herein provided, is hereby authorized to be paid by said board out of the Flood Prevention Bond Issue Fund of the City of Indianapolis.

Section 3. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.

Which was read the first time and referred to the Committee on Public Works.
