I am enclosing herewith fourteen copies of General Ordinance No. 33, 1936, entitled,

It has been stated in the newspapers that our Honorable Mayor John W. Kern has pledged to the Police and Firemen of the City of Indianapolis the restoration of a salary cut made four years ago, and that this cut will be restored starting January 1, 1937.

I have introduced two ordinances before this council asking that the salary cuts be restored, and the last ordinance which I introduced was exactly in line with the pledge made by our Mayor Kern.

If the members of this administration are sincere in restoring any part of these pay cuts, they will vote for this ordinance instead of making newspaper promises.

For about one and one-half years I have made a sincere effort to have the members of this administration give consideration to this ordinance. I am a Republican member of the council and for this reason believe that my efforts have failed. I sincerely believe that this ordinance should not be made a political football by the parties but that just and proper consideration should be given according to the merits of the ordinance.

Inasmuch as the Democratic members of the administration have gene on record as proposing this increase in pay, I feel that they

should get behind this ordinance rather than defer it from month to month for none other than political reasons.
