ORDINANCES ON SECOND READING

Mr. Cable called for General Ordinance No. 40, 1936, for second reading. It was read a second time.

Mr. Cable introduced the following written motion to amend General Ordinance No. 40, 1936:

Indianapolis, Ind., September 21, 1936.

Mr. President:

I move that General Ordinance No. 40, 1936, be amended as follows:

By striking out all of Sections 1 and 2 of said ordinance and inserting in lieu thereof the following:

"Section 1. That the foregoing contract is hereby ratified, confirmed and approved subject to the modifications thereof as herein set forth, and on condition that the same, as modified, be approved by the Board of Public Works and Sanitation and that it be accepted by Indianapolis Railways, Incorporated, in the manner hereinafter provided; that said modifications of said contract are as follows:

"(1) Article 8 shall be modified and amended to read as follows:

[Regular Meeting]

'Article 8. The Company agrees to pay the City for the actual number of miles, or fraction thereof, of streets used by the Company for trackless car operation, where local or intracity street cars are not also being operated on rails, at the rate of \$357.23 per mile per annum from and after March 26, 1936, payment therefor to be made semi-annually as herein provided. On the first day of July and the first day of January of each year the Company shall file with the Board of Public Works and Sanitation a verified statement showing the actual number of miles of such streets used for trackless trolley service during the preceding period, and shall also set forth any additions to such service or any abandonments thereof made during said period, together with the dates upon which such additions or abandonments were made; a copy of such statements shall at said time be filed with the City Controller and the City Civil Engineer. From such statements so filed there shall be computed the average number of miles, or fraction thereof, of such streets actually used for trackless trolley operations during said period and the amount due said City at said rate of \$357.23 per mile per annum; and on said dates the said Company agrees to pay to the City Controller the amount then due for the preceding period.'

"(2) From Article 2 there shall be eliminated the following: "Minnesota Street—East to Ringgold Street.

Ringgold Street—Minnesota Street to Pleasant Run Blvd., N. D.

Pleasant Run Blvd., N. D.-Ringgold Street to Shelby Street.'

"(3) The use of additional streets by Indianapolis Railways, Incorporated, for trackless trolley car operation by permit from the Ecard of Public Works and Sanitation under the provisions of Articles 1 and 2 of said contract shall be subject to prior approval of such permits by the Common Council.

"(4) In case any of said payments set forth in Article 8 are in default for a period of more than sixty days, the City shall, at its election, have the right to terminate said entire contract by resolution to that effect regularly adopted by the Common Council, approved by the Mayor, and a copy thereof served upon the President of Indianapelis Railways, Incorporated.

"Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor, and the said contract as modified in Section 1 of this Ordinance shall become binding between the City of Indianapolis and Indianapolis Railways, Incorporated, upon the filing with the City Clerk of a written acceptance thereof by Indianapolis Railways, Incorporated, and upon approval

of said contract, as modified, by the Board of Public Works and Sanitation; that when so accepted and approved, the said contract shall be effective as of the time therein provided, viz., the 26th day of March, 1936. The said contract, as modified in Section 1 of this ordinance, when accepted and approved as in this Section 2 provided, is hereby in all things ratified, confirmed and approved.

"Section 3. BE IT FURTHER ORDAINED BY THE COMMON COUNCIL, that if for any reason the foregoing modifications and amendments, or any part thereof set forth in Sections 1 and 2 of this ordinance, shall be held void, ineffective or in any sense not binding, then in any such event the entire contract shall in all things be null and void."

That when so amended, said General Ordinance No. 40, 1936, do pass.
