CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of One Hundred Thirty Thousand Eight Hundred Seventy-five Oollars and Forty-five Cents (\$130,875.45), received on October 5, 1936, from the State of Indiana as revenue under the Gasoline Tax, be and the same is hereby appropriated, allocated and distributed to the following departments of the City of Indianapolis, in the amounts specified, in accordance with the provisions of Section 3A of General Ordinance No. 70, 1935:

## INTRODUCTION OF GENERAL ORDINANCES

By the Board of Public Works and Sanitation:

### GENERAL ORDINANCE NO. 78, 1936

AN ORDINANCE amending General Ordinance No. 25, 1936, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That General Ordinance No. 25, 1936, be amended to read as follows:

### “GENERAL ORDINANCE NO. 25, 1936

AN ORDINANCE authorizing the Board of Public Works and Sanitation, through its duly authorized purchasing agent, to

purchase, in conjunction with the Works Progress Administration of the United States Government, certain heated concrete and to expend therefor a sum not exceeding Seven Thousand Two Hundred Fifty Dollars (\$7,250.00), and fixing a time when the same shall take effect.

WHEREAS, the purchase of one thousand (1,000) cubic yards of thirty-five hundred (3,500) lb. heated concrete is contemplated by the Board of Public Works and Sanitation the Works Progress Administration of the United States Government for use in the Pogue's Run sewer; and

WHEREAS, the total estimated cost of said heated concrete is Eighteen Thousand One Hundred Twenty-five Dollars (\$18,125.00); and

WHEREAS, the said Works Progress Administration proposes to contribute and pay three-fifths ( $3/5$ ) of the total cost of said heated concrete in conjunction with the contribution and payment by the Board of Public Works and Sanitation of two-fifths ( $2/5$ ) of said total cost of said heated concrete; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF  
THE CITY OF INDIANAPOLIS, INDIANA::

Section 1. That the Board of Public Works and Sanitation of the City of Indianapolis, through its duly authorized purchasing agent, is hereby authorized to contribute and expend in the purchase of one thousand (1,000) cubic yards of thirty-five hundred (3,500) lb. heated concrete, a sum of money equivalent to two-fifths ( $2/5$ ) of the total cost thereof, said sum so to be contributed and expended not to exceed the sum of Seven Thousand Two Hundred Fifty Dollars (\$7,250.00), and said sum to be conjoined with a sum of money equivalent to three-fifths ( $3/5$ ) of said total cost of said heated concrete contributed and expended by the Works Progress Administration of the United States Government in said purchase of said heated concrete.

Section 2. That the sum of Seven Thousand Two Hundred Fifty Dollars (\$7,250.00), to be used and expended by said Board of Public Works and Sanitation in the purchase of said heated concrete as in the manner herein provided, is hereby authorized to be paid by said board out of the Flood Prevention Bond Issue Fund of the City of Indianapolis.

Section 3. This ordinance shall be in full force and effect from and after its passage and approval by the mayor."

**GENERAL ORDINANCE NO. 79, 1936**

AN ORDINANCE authorizing the Board of Health to purchase certain equipment for the Flower Mission Hospital and John Maurice Butler Dispensary, etc., and fixing a time when the same shall take effect.

**BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:**

Section 1. That the Board of Health of the City of Indianapolis is hereby authorized to perform and/or purchase and install, in the manner prescribed by law, the articles, materials and matters as stated hereinafter, to be paid for out of funds heretofore received from the Butler-Snow Trust and the Indianapolis Flower Mission and the U. S. Government and funds that may be received from the U. S. Government under a grant to aid in same.

1. Drinking fountain and cooler.
2. Doctor's paging system.
3. Painting interior plaster walls.
4. Window shades.
5. Terrazzo floor treatment.
6. Elevator stops.
7. Water pump.
  
8. Equipment, as per the list compiled by the Business Manager of the City Hospital and now on file at the offices of the City Hospital.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

GENERAL ORDINANCE NO. 80, 1936

AN ORDINANCE amending sub-sections (b) and (c) of Section 10 of General Ordinance No. 96, 1928, commonly known as the Traffic Ordinance, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That sub-section (b) of Section Ten (10) of General Ordinance No. 96, 1928, be amended to read as follows:

“(b) Red, when shown in the center lens of a three (3) lens signal while Green or “Go” signal is also being shown, and “Caution” or “Change” when shown following the Green or “Go” signal—Traffic facing the signal shall stop before entering the intersection unless so close to the intersection that stop cannot be made in safety.”

Section 2. That sub-section (c) of Section Ten (10) of General Ordinance No. 96, 1928, be amended to read as follows:

“(c) Red, when shown, except as above described, in any lens, or any number of lenses of any signal, or “Stop”—Traffic facing the signal shall stop before entering the intersection and remain standing until the Green or “Go” signal is shown alone.”

That the action of the Board of Public Safety on the first day of December, 1936, in executing, on behalf of the City of Indianapolis, a written contract between the City of Indianapolis and Warren Township of Marion County, State of Indiana, in which the City of Indianapolis agrees to furnish, for the protection of the property of the citizens of said township situated outside of the corporate limits of all cities and towns in said township, such of its fire apparatus and fire fighting service to said Warren Township as may be reasonably available for said township, and in which said contract said city agrees to furnish said fire apparatus and fire service for a period of two (2) years from the first day of January, 1937, to the 31st day of December, 1938, for and in consideration of One Thousand Two Hundred Dollars (\$1,200.00), to be paid to the City of Indianapolis for each of the years 1937 and 1938, a sum of Six Hundred Dollars (\$600.00) to be paid semi-annually on July 1st and December 31st of each year, which said written contract has been approved by the Mayor and is now on file in the offices of the Board of Public Safety, is hereby ratified, approved and confirmed.

Section 5. That the action of the Board of Public Safety on the first day of December, 1936, in executing, on behalf of the City of Indianapolis, a written contract between the City of Indianapolis and Center Township of Marion County, State of Indiana, in which the City of Indianapolis agrees to furnish, for the protection of the property of the citizens of said township situated outside of the corporate limits of all cities and towns in said township, such of its fire appa-

tus and fire fighting service to said Center Township as may be reasonably available for said township, and in which said contract said city agrees to furnish said fire apparatus and fire service for a period of two (2) years from the first day of January, 1937, to the 31st day of December, 1938, for and in consideration of Two Hundred Fifty Dollars (\$250.00), to be paid to the City of Indianapolis for each of the years 1937 and 1938, a sum of One Hundred Twenty-five Dollars (\$125.00) to be paid semi-annually on July 1st and December 31st of each year, which said written contract has been approved by the Mayor and is now on file in the offices of the Board of Public Safety, is hereby ratified, approved and confirmed.

Sectiton 6. That the action of the Board of Public Safety on the first day of December, 1936, in executing, on behalf of the City of Indianapolis a written contract between the City of Indianapolis and Wayne Township of Marion County, State of Indiana, in which the City of Indianapolis agrees to furnish, for the protection of the property of the citizens of said township situated outside of the corporate limits of all cities and towns in said township, such of its fire apparatus and fire fighting service to said Wayne Township as may be reasonably available for said township, and in which said contract said city agrees to furnish said fire apparatus and fire service for a period of two (2) years from the first day of January, 1937, to the 31st day of December, 1938, for and in consideration of Two Thousand Five Hundred Dollars (\$2,500.00), to be paid to the City of Indianapolis for each of the years 1937 and 1938, a sum of One Thousand Two Hundred Fifty Dollars (\$1,250.00) to be paid semi-annually on July 1st and December 31st of each year, which said written contract has been approved by the Mayor and is now on file in the offices of the Board of Public Safety, is hereby ratified, approved and confirmed.

Section 7. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

AN ORDINANCE of the City of Indianapolis, Indiana, authorizing the issuance and sale of bonds of said city designated, "City of Indianapolis, City Hospital Service Building Bonds of 1937—First Issue," and matters connected therewith, appropriating the proceeds of the sale of said bonds to the Department of Health and Charities of said city; and fixing a time when the same shall take effect.

WHEREAS, the Board of Health of the City of Indianapolis, on the 20th day of November, 1936, passed a resolution to the effect that a new Service Building unit was indispensable to the safe and efficient operation of the City Hospital and that the same should be immediately constructed and equipped thereat, and that certain condemned buildings on the grounds of said hospital be razed and removed in preparing a site for the same, and that temporary corridors be erected for use during the progress of the construction of such new Service Building unit; and

WHEREAS, it is, by the Common Council of the City of Indianapolis deemed necessary and proper for the best interests of the City of Indianapolis and its inhabitants to improve the conditions with reference to the proper and adequate health protection at said City Hospital; and

WHEREAS, for said purposes it is deemed necessary and advisable at the present time to construct and equip a new Service Building unit on the grounds occupied by the City Hospital and owned by



the City of Indianapolis, and to immediately raze and remove certain condemned buildings thereon; and

WHEREAS, the United States of America has offered to aid in financing the construction of such a new Service Building unit by making a grant to the City of Indianapolis in the amount of forty-five per cent of the cost of such a project upon completion, as determined by the Federal Emergency Administration of Public Works, but not to exceed Seventy Thousand Six Hundred Fifty Dollars (\$70,650); and

WHEREAS, in order to assure the benefits of said grant, it is important that funds be made immediately available to the Department of Health and Charities; and

WHEREAS, there are not now, and will not be, sufficient funds in the treasury of said city with which to provide the additional amount of the approximate cost of constructing and equipping such new Service Building unit and to pay for the costs of preparing the site upon which said new Service Building unit is to be located and to pay for the cost of erecting temporary corridors during the progress of such construction, the total costs of which undertakings are estimated to be One Hundred Sixty-five Thousand Dollars (\$165,000); and

WHEREAS, it will be necessary for the City of Indianapolis to borrow for said purposes the sum of Ninety-five Thousand Dollars (\$95,000), and to provide for and secure the repayment thereof, and to evidence said indebtedness by the issuance and sale of its bonds in said amount, payable from the general funds or from the Sinking Fund of said city, or as may be required by law; and

WHEREAS, the Common Council now finds that an extraordinary emergency exists for the appropriation of additional sums not provided for in existing budgets and levies; NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That there shall be issued and sold, for the purpose of obtaining funds with which to construct and equip a new Service Building unit at the Indianapolis City Hospital, or to aid in the construction and equipment of the same, and to pay costs of razing and removing condemned buildings in preparing a site for the same, and to pay costs of erecting temporary corridors at the City Hospital for use during the progress of the construction of such new Service Building unit, ninety-five (95) negotiable, direct, general obligation bonds



of the City of Indianapolis, in the sum of One Thousand Dollars (\$1,000) each, numbered from One (1) to Ninety-five (95), both inclusive, and designated as "City of Indianapolis, City Hospital Service Building Bonds of 1937—First Issue." All of said bonds shall be dated as of January 25, 1937. Said bonds shall mature and be paid as follows Ten (10) bonds on July: 1, 1938, and five (5) bonds each six (6) months thereafter until all of said bonds are paid.

Said bonds shall bear interest at a rate not exceeding five per cent (5%) per annum, the exact rate to be determined by bidding as hereinafter more particularly provided. The first interest shall be payable July 1, 1938. Thereafter the interest on said bonds shall be payable semi-annually on the first day of January and the first day of July of each year for the period of said bonds. Said installments of interest shall be evidenced by interest coupons attached to said bonds.

Section 2. Said bonds and the interest coupons attached thereto shall be payable at the office of the Treasurer of the City of Indianapolis, in said city, in lawful money of the United States of America. Said bonds shall be signed in the name of the City of Indianapolis, by the Mayor of said city, countersigned by the City Controller, and attested by the City Clerk, who shall affix to each of said bonds the corporate seal of the city. The interest coupons attached to said bonds shall be executed by placing thereon the fac simile signatures of the Mayor and the City Controller, who, by the signing of said bonds, shall adopt as and for their own proper signatures their fac simile signatures appearing on said coupons. Said bonds shall, in the hands of the bona fide holders, have all the qualities of negotiable instruments under the law merchant.

Section 3. The form and tenor of said bonds and the interest coupons to be attached thereto shall be substantially as follows, all blanks to be filled in properly prior to delivery:

Section 4. On final adoption of this ordinance, the City Clerk shall immediately cause to be published and posted, in the manner required by law, a notice of the determination of the city to issue all of the bonds authorized by this ordinance and to incur the debt evidenced thereby. Said notice shall be published once each week for two weeks in two local newspapers, and shall be posted in three public places.

Section 5. Said bonds shall be offered for sale by the City Controller as soon as may be done after the final adoption of this ordinance. Prior to the sale of any of said bonds the City Controller shall cause to be published a notice of the sale of said bonds, once each week for two weeks in two (2) local newspapers. The date fixed for the sale of said bonds shall not be earlier than seven days after the last of said publications. Said bond sale notice shall state the time and place of sale, the purpose for which said bonds are issued, the

amount thereof, the maximum rate of interest thereon, the time of payment, and the terms and conditions upon which bids will be received and the sale made, and such other information as the City Controller shall deem necessary.
