Allowed James Vanblaricum Sixty \$ to be expended in the repair of the Bridge over Pogues run on Pennsylvania Street: in digging a ditch on Market Street and on the roads leading from the town through the donation.

(Issued June 18, 1839)

On Motion of Mr. Seibert:

Resolved That the grade of the side walks on Washington Street And on the north side thereof between Pennsylvania and Meredian Streets be as follows: from the East end of Mr. I. Philips pavement to the West end of Mr. I Blakes shall be a regular and continuous grade and that East of the Alley, from the Alley East to Pennsylvania the grade shall be at the front line of the lot ten inches above the centre of the street.

A Petition was presented by Jas. M. Smith and another on the subject of the draing of the streets and damage by water which was on motion of Mr. Rooker laid on the table.

And the Council adjourned.
