Resolved That a committee be appointed draft a memorial to be presented to the next General assembly praying the amendment of the act of incorporation.

The Committee appointed consists of Messrs Lockerbie McCluer Norwood & Sullivan.

On Motion of Mr. McCluer

Ordered that the Committee on Wells be directed to have a pump placed in the Well in front of Governor Rays row of buildings on Washington Street - provided Ray relinquishes all claim to said well and if not said Committee shall cause said well to be filled up.

On Motion of Mr. Norwood

Resolved that the Marshal strike from the delinquent list all persons names he may know to be exempt from taxation.

A Communication was received from S. Munsel which was referred to Mr. Sullivan, with instructions that Mr. Sullivan to settle all matters of account with said Munsell.

On Motion of Mr. Rooker

Resolved That a Committee be appointed on behalf of the Common Council to confer with Mr. Little on the subject of a Compromise of the Suit now pending between the Council and said Little - And that said Committee be instructed to require said Little to pay the License from April 1838 to the present time and also pay all costs including the Attorneys fees incurred by the Council.

Messrs Lockerbie & Sullivan were appointed said Committee
