Resolved That Mr. Frey be permitted to erect a fence in front of his house on the alley Six feet from the front subject however to be removed at the will of the Council.

On Motion of Mr. Norwood

Resolved That the Marshal cause to be erected foot bridges on the East Side of Illinois Street where Market Street crosses the same.

On Motion of Mr. McCluer

Resolved That a committee be appointed to examine the work and settle with the Contractor for repairing well, pumps etc. and report thereon at next meeting of Council

Messrs. McCluer, Norwood Sullivan & Lockerbie were appointed said Committee

On Motion of Mr. Lockerbie

Resolved That the Common Council will forbear to prosecute John Crowder and Henry Fushaupt for retailing liquors etc. provided they desposit \$100. each with Treasurer to pay for license so soon as they obtain county license - provided they do so at the next meeting of the County board.

Allowed Shay & Fulks \$3:50 for work done on Streets as per account.
