Indianapolis March 29. 1841

The President of the Common Council William Sullivan and the Councilman of the Second Ward Samuel Goldsberry and the Councilman of the fourth Ward Andrew A. Loudon and the Councilman of the Sixth Ward Carey H Boatright duly elected Councilmen of the Common Council of the town of Indianapolis on Saturday the 27th day of March A.D. 1841 pursuant to the several acts of the General Assembly of the State of Indiana for the incorporation of said town, appeared and presented their certificates of election, with the proper oaths endorsed thereon pursuant to law.

Councilmen Matthew Little, Jacob Cox and George Norwood were also in attendance

Whereupon the Common Council appointed Hervey Brown Secretary of the Council, by a unanimous vote, for the term of one year,

Thereupon Hervey Brown appeared was duly sworn into office and entered upon the discharge of his duties as Secretary.

On Motion of Mr. Norwood

Messrs Loudon and Goldsberry were added to the committee for the purchase of a Hose Carriage heretofore appointed.

On Motion of Mr. Norwood

Resolved That a committee of three be appointed to cause a survey to made of Maryland Street and the alley running South from the Washington Hall with the view of having the work heretofore ordered completed

Messrs Goldsberry, Cox & Loudon were appointed said committee On motion Mr. Norwood was added to said committee.

On Motion of Mr. Cox

Ordered that \$50. be appropriated to the repairs of Maryland Street and the alley running south from Washington Hall, in addition to what has heretofore been appropriated for that purpose.
