The following petition was presented:

"To the Hon, Common Council of the town of Indianapolis, The undersigned owners of property on the East side of Illinois Street, between Washington Street & Maryland Street respectfully represent that the "public interest will be promoted" by grading - curbing and paving the side walk on the section of the Street above named Your petitioners therefore pray your Honorable body to cause the same to be estimated and the said improvement to made complete by the first of October proximo, & cause the expense of the same to be assessed & Levied upon the property fronting the said improvement agreeably to the ordinance in such cases made and provided June 23rd 1841.

The above being 245 feet and more than one half of the whole number of feet owned between the points named in said petition the prayer of said petition is granted and the grading etc. named

in said petition ordered to be completed by the first day of October next; And the Town Surveyor is ordered to make all necessary surveys and estimates pursuant to the Ordinance on the subject of side walks, and further that the proper officer proceed to have said work completed by the time and in the manner aforesaid.

Allowed James Green \$100. on part for the work on Maryland Street per contract etc.

Ordered That the Marshal notify the owners & agents of the property in the rear of the Union Hotel to abate the pond of a nuisance on said property otherwise that the Marshal abate the same and it being declared a nuisance.

Ordered That \$100 be and the same is hereby appropriated to finish Virginia Avenue and that the Marshal proceed to expend the same under the direction of the Committee heretofore appointed.
