On Motion of Mr Boatright the petition of Henry Bradley and others heretofore presented was taken from the table which is in

the following words & figures

"To the Common Council of the town of Indianapolis The undersigned your petitioners owners of property, on the south side of Maryland between Meredian Street and the Canal would respectfully pray that your Honorable body make such order or laws as will compel and authorize the owners of property fronting aforesaid Street to grade and gravel said side walk on the south side of Maryland Street between Meredian Street and the Canal as aforesaid in conformity with the laws and ordinances regulating side walks etc And your petitioners further ask that your Honorable body will grant the privilege of taking gravel from Louisiana Street in the event that it should be necessary so to do and your petitioners will ever pray

L.Dunlap presented a petition praying for permission to fill the side walk on the north side of lots Mos. 1. 2 & 5 in Block No. 77 with earth and that he take the earth from Alabama Street south of Bridge over Pogues run: which was pranted and said petitioner directed to do the same under the direction of the Engineer and Councilman from the second ward.

Isaac Kinder asked and obtained permission to take earth and gravel from Alabama Street south of Pogues run for the improvement
