Ordered that the Marshal cause a gravel side walk to be made around the east side of the Governors Circle from the Council Chamber to the Hay scales.

Allowed Isaac Kinder \$0:60 money improperly collected of him as taxes for the past year.

Council met: present, David V. Cully President, M. Little S. Goldsberry George Norwood J. Cox and C H Boatright Councilmen.

On Motion of Mr. Boatright

Resolved That a committee be appointed to superintend the hauling or taking gravel from Louisiana Street between Meridian and Illinois Streets and that Morris Morris be requested to act with and assist said committee in the discharge of said duty.

Messrs Cox & Loudon were appointed said committee

Matthew Little and others presented a petition praying the privilege of gravelling and improving East Street on the East side thereof south of Washington Street and that said petitioners may take gravel from New Jersey or Alabama Street south of Pogues run.

Ordered that the prayer of said petitioners be granted.
