

Council Chamber
Indianapolis December 5. 1842.

Council met: present Messrs Cully President Black Goldsberry, Nowland, Rickards and Rooker of the Council.

The President laid before the Council The Treasurers monthly report which was read and received.

The President presented the Weighmasters monthly report which was received.

The President presented the Petition of Messrs Little & Biddle praying that they be licensed as town Auctioneers for one year from 20 November 1842. When the prayer of said Petition was granted and the Secretary directed to issue such license upon their having complied with the ordinances on that subject.

Mr Rickards presented an account in favor of B. Pottage for \$5:12 which on motion of Mr Black was referred to the committee on claims.

Mr Black from the committee on Markets & Market houses to whom the subject had been referred, in accordance with instructions reported an ordinance entitled "An ordinance To repeal the twenty third section of an ordinance entitled "An ordinance For the regulation of the Markets in the town of Indianapolis and for other purposes" ordained and established 14 day of June 1839" which was read amended ordained passed and established and ordered to be published.

The President laid before the Council Little & Biddles report as town Auctioneers which was read and received.

The President presented the Petition of F H Dunn & others on the subject of side walks - On motion the prayer of said petition was granted and the State of Indiana directed in pursuance to the prayer of said petition to cause a gravelled side walk to be made from Washington to Market Streets on the East side of the State house square and that the Marshal make gravelled walks across Tennessee Street on the South side of Washington Street and across Market Street on the West side of Tennessee Street.

On Motion of Mr. Rooker - Ordered that the Marshal make a gravel walk from the West end of the West Market house across Ohio Street to a point near John Elders residence.

The President presented the Supervisors report by which it appeared that the Supervisor had received \$141. of the unexpended road tax of the year 1841 and had expended \$267:25 under the direction of the Council being \$126:25 more than the unexpected balance of the year 1841 When on Motion

Allowed R.C. Allison \$126:25 - being for money expended as Supervisor - as follows - in the first ward \$4:75 - in the second ward \$27:93 in the 3rd ward \$11:91 - in the fourth ward \$41:81 in the fifth ward \$20:92 and in the sixth ward \$13:93 - which amounts are to be deducted from the road tax of the several wards for the year 1842 -

Allowed R C Allison \$5: for making travelled walks as per account.

Council met upon call: present Messrs Cully President Black Nowland and Goldsberry of the Council.

Mr Young from the committee appointed by and on behalf of the Marion Fire Engine Company appeared before the Council and preferred charges against James Vanblaricum messenger of the Fire department representing that said messenger after notice had neglected to keep the Engine in order and had otherwise failed in the discharge of his duty thereby renderin the Engine inefficient; and requesting that said James Vanblaricum be removed from said office and that some suitable person be appointed to said office: said Company suggested the name of David Cox as a suitable person to fill said office: When -

On Motion of Mr. Nowland

Resolved That in view of the representation of the Marion Engine Company that the appointment of James Vanblaricum be and the same is hereby abrogated and put to an end and that David Cox be and he is hereby appointed messenger to the fire department for and during the unexpired time of said officer, to discharge the same duties and be entitled to the same compensation now required of and paid to said messenger

Ordered That the Secretary notify David Cox of the appointment
