Indianapolis August 12, 1843.

Council met: All the members present except Nowland.

Mr. Black presented the Treasurer report which was read & received.

Mr. Rickards from a Committee on the subject of improvements on the Pond Drain North East of Indianapolis -- reported the probable cost of making said improvements at \$150.00 or \$175; and also that there had been \$75. subscribed by the Citizens of the north west part of the City, to be applied to said purpose, with a recommendation that the sum of \$100. be appropriated to aid in finishing said Work. When

On Motion of Mr. Rickards, it was

Resolved That an appropriation of \$75. be made, to aid the Citizens in the north west part of the City, to repair permanently the Pond drain. The said sum with a like amount raised by private donation to be expended under the direction of a committee. Said \$75. hereby appropriated, payable one half the 15th day of September and the balance the 15th day of November, next.

Messrs. Rickards & Rooker of the Council and David Dawson on the part of the Citizens interested, were appointed said Committee.

Indianapolis, September 2nd 1843.

Council met. Present Messrs. Culley President, Goldsberry, Louden Nowland and Rooker of the Council.

Mr. Nowland was excused of absence on the last regular meeting.

The President laid before the Council the Petition of A. L. Hunt & Co. praying that they be licensed as town Auctioners for one year. Then the prayer of said Petitioners was granted, and to take effect and the Secretary directed to issue such license, upon their complying with the Ordinances on that subject.

The President laid before the Council the Petition of James M. Smith and Uriah Jame praying to be released of the fine assessed against John Jackson wherein they stand as securities. On reading the Petition Mr. Goldsberry moved to grant the prayer of the Petitioners upon the condition that they pay the cost within thirty days from this date. Which motion prevailed.
