Mr. Nowland was excused of absence on the last regular meeting.

The President laid before the Council the Petition of A. L. Hunt & Co. praying that they be licensed as town Auctioners for one year. Then the prayer of said Petitioners was granted, and to take effect and the Secretary directed to issue such license, upon their complying with the Ordinances on that subject.

The President laid before the Council the Petition of James M. Smith and Uriah Jame praying to be released of the fine assessed against John Jackson wherein they stand as securities. On reading the Petition Mr. Goldsberry moved to grant the prayer of the Petitioners upon the condition that they pay the cost within thirty days from this date. Which motion prevailed.
