Council Chamber  
Indianapolis July 10, 1847

At a special meeting of the council, held this day at their chamber to take into consideration measures to prevent the extension of the Small Pox in the city, the President being absent, Mr Gates was called to the chair -

On Motion the following resolutions were adopted to wit --

Resolved, That in view of the various conflicting Opinions entertained by citizens in reference to the proper course to be pursued, touching the case of Small Pox, now existing in the family of Mrs Israel Phillips it is not expedient for the city council to take any measures for the removal of the patient, but in order to subserve the public welfare, the Marshal is hereby directed to place a red flag upon the house occupied by Mrs. Phillips and to take such other steps as he may deem necessary to isolate said house from public intercourse.



Resolved, That Messrs Cady, King, & Tutewiler, be and they are hereby appointed a committee to select a suitable piece of Ground, within the limits of the city not less than one acre on which to erect a building of sufficient dimensions to accommodate not less than six persons which building shall be , and is hereby set apart, exclusively for the use of persons laboring under the Small pox or varioloid or other contagious or infectious diseases; and said committee are authorized and instructed to proceed with all diligence in the selection of Ground, and the erection of a building, and other appurtenances for the purpose aforesaid.

Resolved, That the sum of One thousand dollars, is hereby appropriated to be expended under the direction of said committee in procuring said ground, building, and all necessary furniture, provisions, nurses, medical, & other expenses, a detailed report of which expenditures shall be submitted by said committee to the city council.

Resolved That Messrs Mothershead, Dunlap & Bobbs. are hereby constituted a "Board of Health", for the city of Indianapolis. for the term of One year. whose duty it shall be during the existence of any contagious or infectious diseases, within the limits of the city to publish written or printed bulletins of the progress of such diseases, by posting the same in not less than three places of public resort in the city and further to make such suggestions in writing to the city council in regard to such diseases, their prevention, and treatment, as they may deem necessary to the public welfare.

Ordered That the Secretary cause fifty copies of the proceedings of this meeting to be published in hand bill form, And that the Marshall cause the same to be posted in the City

And the Council Adjourned.
