Dr Bobbs - from the Committee appointed by the citizens meeting of the 7" inst to prepare a plan of General Sanative measures for the consideration. of the council presented a report suggesting such plan. Whereupon it was:

Ordered That the report be concurred in, and that the Secretary cause five thousand Copies thereof to be printed, in pamphlet form for distribution.

Resolved. That Messrs King, Tutewiler & Rooker, be and they are hereby appointed a committee to prepare a suitable plan for the construction of a city hospital, and that they be authorized to issue notices for the reception of sealed proposals for the construction of said House at the earliest practicable period, and report from time to time their action in the premises, to the city council

On Motion of Mr King.

Resolved That one physician be appointed to each ward for the purpose of performing the Operation of Vaccination upon all those who have not been previously submitted to said Operation. Whereupon the following gentleman are appointed towit.

Council met pursuant to adjournment-- Present Messrs Gates, Tutewiler, King, Morris, & Wingate

The President being absent, Mr Morris was appointed President protem.

Mr Tutewiler, from the committee appointed at the last meeting, to prepare an Ordinance &c reported an Ordinance entitled, "An Ordinance to establish a Board of Health for the city of Indianapolis and to prevent the spread of contagious or malignant diseases in said city -"

Which was read, ordained and established to take effect from and after its publication as required by the Charter.-

Ordered That the Board of Health be directed to report in future the names and residence of those who may be infected with the Small pox. or varioloid.

Ordered That the Treasurer execute to James Van Blaricum a receipt in full for the taxes assessed against him by the common council of the town of Indianapolis for the year 1846. and the by the city council for the year 1847. for General purposes upon his crediting the judgment in his favor against the Common Council in the Marion Circuit Court to that amount.

Ordered That James Blake be and he is hereby directed to widen the gates over Pagues Run on his property fronting Meridian Street to a width equal to the Bridge over said run on said street, and in default thereof within ten days after notification by the Commissioner of Streets that said Commissioner perform that service at the expense of Mr Blake. ---
