Mr King introduced an Ordinance entitled "An Ordinance to prevent the firing of shavings or other combustible material, after a certain hour within the limits of the city of Indianapolis," which was read, ordained and established to take effect from and after its publication as required by the charter.

On Motion, The President was requested to draft an Ordinance to provide for the inspection of Flour and the cording of Wood within the limits of the city, to make report thereof at the next meeting of the council.

The President laid before the Council the following petition to wit.

To the City Council of Indianapolis

The undersigned Owner of Out-lots Nos. 77. & 78. situate in the city of Indianapolis being desirous of making a sidewalk twelve feet in width in front of said lot very respectfully prays, that your honorable body will make an Order directing the city Engineer to set grade marks for the same and notify the Street commissioner thereof pursuant to the provisions of Ordinance No 2. adopted June 21 1847.

The petition being read It was Ordered That the prayer of the petitioner be granted. and that the city Engineer conform said side walks to the grade of the National Road, Opposite thereto, making the same twelve feet in width. --

Ordered. That the commissioner of Streets, proceed forthwith, to Open a passage suitable for carriages through the Embankments, on each side of Alabama Street, where the same is intersected by Ohio Street. which said embankments, were made by grading said Alabama Street -

Ordered That the City Engineer make estimates on Alabama Street from Washington Street to South Street, and on Virginia Avenue with a view of ascertaining whether there be any surplus earth on said street, and report to Mr Isaac Kinder, who is hereby authorized to remove said Surplus earth and place it on the sidewalks around Square Number Seventy eight

Ordered That, Chas W Cady, be allowed to take earth on the National Road, Opposite the property of John Heim, for the purpose of grading the front of Outlots Nos 77.& 78.

On Motion the Council proceeded to elect a clk to the E Market, to fill the vacancy Occasioned by the resignation of S Barbee Sr. Whereupon on the second ballot. Jacob Miller was elected said clk. to serve until the next regular election of officers

The President Presented an Ordinance regulating Wood Wagons, and the measurement & sale of Fire Wood, which was read & adopted to take effect & be in force from and after the 1st day of May 1848.

And the council adjourned.
