The Council met pursuant to adjournment. Present. George A Chapman, President, Messrs Tutewiler, Alford, Eaglesfield & Sibert Councilmen.

The object of the meeting being further to consider the subject of Free Schools. Sundry proposals for the sale of lots for school purposes were received and examined.

On Motion of Mr Tutewiler

The North East corner lot of the Hospital Square, was selected as the site for the Free School House in Ward No 1. at the sum of Four hundred & Seventy five dollars.

On Motion by Mr Tutewiler

That part of Lot No 1 in Square No 37 offered by A Harrison Esq was selected as the site of the Free School House in Ward No 2. upon the condition, that the appraised value thereof does not exceed Six hundred dollars.

On motion by Mr Alford

A certain part of Lots Nos 7 & 8 in Square number 27. offered by O. Foote, Esq. was selected as the site for the Free School House in Ward No 3. at the sum of Five hundred dollars.

On motion by Mr Eaglesfield

Lot No in Square or Out Lot No 147. offered by H Griffith Esq was selected as the site, for the Free School House in Ward No 4. at the sum of Two hundred and Seventy five dollars.

On motion by Mr Seibert,

Lot No in Square No 81. offered by W Smith, Esq was selected as the site for the Free School House in Ward No 7. at the sum of Two hundred dollars.

On motion by Mr Tutewiler. Mr Jno Wilkens was appointed the appraiser On behalf of the Council to appraise the property offered by Mr Harrison.

The council met pursuant to a call of the President. Present George A. Chapman, President. Messrs Tutewiler, Alford, Mayhew and Sibert of the council.

The object of the meeting having been explained by the President. It was

Ordered. That Messrs Mayhew & Tutewiler, be a committee in conjunction with the city Attorney to examine the titles of property offered to the city council of Indianapolis, for school purposes; and upon finding the same valid, that they report the same to the President of said council, and if he approve the same, he shall draw an order in favor of the grantor in the amount agreed by the city council; to be paid out of the school fund. - said order to be countersigned by the Secretary, and a record thereof with the deeds shall be deposited with the city Treasurer, and subject to all the injunctions by law required of said Officer.

And the Council adjourned to the next regular meeting to be held On the first Monday in December next at 2 oClock P.M.
