

The petition being read

It was Ordered. That the Council will meet on the 1st Monday in July 1849, for the purpose of considering and determining the Matters embraced in said petition, and that the Secretary give publication as required by the ordinance in relation to the connection and construction of Rail Roads through the city of Indianapolis.

Ordered. That the Committee on claims be instructed to compromise if practicable the matter in difference between the Council and A. H. Davidsion in reference to the sale of the Engine House of the Good Intent Engine -- also to compromise the difficulties between the Council and John S. Ketcham with respect to the sale of lots in the Market space in Square No. 48.

Ordered. That all strolling Musicians, signers, organ players, and persons giving exhibitions of any kind in the public streets, and taking money therefor, shall be declared nuisances and on conviction thereof, be fined not less than one dollar each for the first offense, and the fine to be increased at the discretion of the Mayor for any subsequent offense.

The Proceedings of last meeting were read and approved.

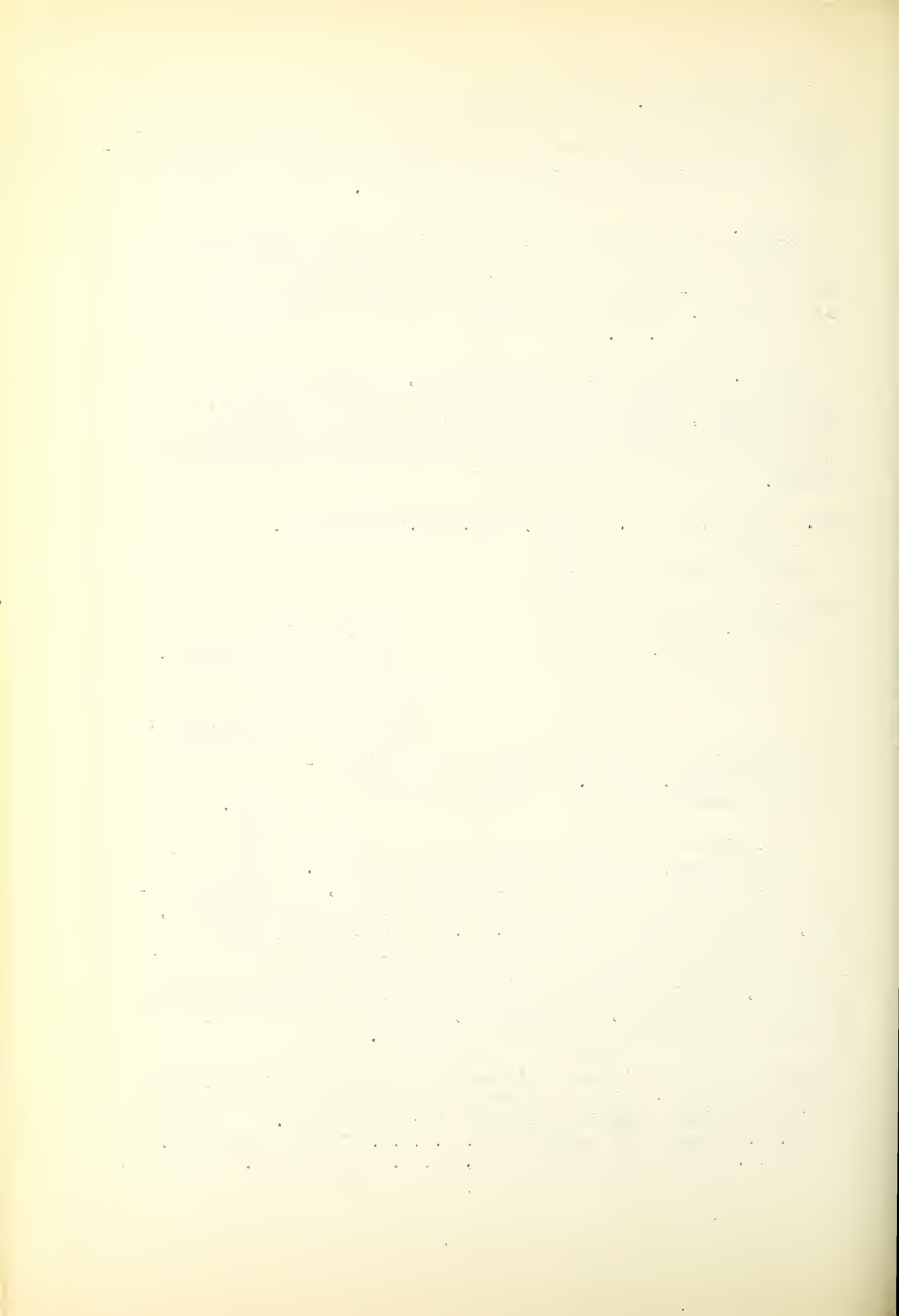
The President laid before the Council the following petitions:

"To the Hon., the City Council of Indianapolis.

The Petition of the Subscribers represent, that they are desirous to have the privilege of grading the sidewalks on the North, West, and South sides of Block No. 41. in Indianapolis, lying on Ohio, New Jersey and Market Streets; and therefore pray that an order may be granted allowing the same and fixing the grade of said Sidewalks, and also of the alleys running through the centre of said block, north and South, East and West, with the privilege of grading so much as the subscribers may deem expedient.

(Signed) Isaac Coe, who owns all the West side of said square, 8/10 of the North side - 5/12 of the South side, and one half the ground adjoining the alley running North & South; East & West.

Ordered.

That the prayer of the petitioners be granted and that the City Engineer make survey and set grade marks for said improvement, and notify The Street Commissioner as required.

## On Motion by Mr. Montague

Resolved. That Isaac Kinder be permitted to use the dirt to be taken from the side gutter on the east side of Alabama Street south of Pogues Creek to fill his sidewalk, provided he shall make said gutter at his own expense, and complete the same so as to carry off the water in strict conformity with the grade stakes set by the Engineer.

## On Motion by Mr. Gillespie

Resolved. That R. R. Underhill be permitted to take dirt from the sidewalk on the East side of Pennsylvania Street west of the Madison & Indianapolis Rail Road depot, to raise his sidewalk on the same street provided, he grades said sidewalk so as to leave it in a good passable condition.

## On Motion by Mr. Sulgrave

Resolved, That A. W. Morris, under the inspection and with the aprobation of the Councilman of the 6th Ward, be permitted to grade the West side of that part of Meridian Street in front of said Morris' property and that he be permitted to use the earth, taken from said Street.

216. Allowed, Sims A. Colley \$13.25 for removing nuisances.

## On Motion by Mr. Sulgrave

Resolved, That the person having the use of the south room of the Council chamber for a school, be notified to quit the possession of said room at the expiration of the present quarter, or sooner if possible, and that said room thereafter be tendered to the Mayor for the transaction of his Mayoral services.

Ordered. That the suit instituted before the Mayor, against A.W. Morris for removing earth from certain Streets without permission from the Council, be and the same is hereby dismissed.
