The President laid before the Council the following petition: viz. "To the Hon, the City Council of Indianapolis.

The undersigned citizens of Indianapolis respectfully pray your honorable body to order a survey or re-survey to be made to ascertain, whether the water running from the swamp, north of said city, could not be so diverted as to prevent any portion of it from running into & through the city, and that the Engineer be ordered to report as to the most suitable route or routes that should be taken & also the amount that it would cost to effect the object.

That a Tax of twenty five cents including the additional tax of ten cents voted by the citizens on the 9th day of June 1849, as certified by the judges and clerks of the election then held, be levied on the assessment returned by the city assessor for the year 1849, for general purposes; twelve cents be levied thereon for school purposes, One dollar on each person chargeable with a poll tax - One dollar on each person chargeable with a road tax and 50 cts. on each dog so returned as aforesaid.

On Motion, Resolved. That the Council will meet on the 23rd day of July inst at 3 o'clock P. M. for the purpose of hearing and determing all appeals that may be taken from the assessment returned by the city assessor for the year 1849.

The President laid before the Council the following petition: To the Hon. Council of Indianapolis.

The undersigned respectfully requests your honorable body to grant him permission to take dirt from the sidewalks on Vermont Street, between Pennsylvania and Meridian Streets to grade the sidewalk on the south side of Vermont street opposite his lot.

The President laid before the Council the following ordinance viz.

An Ordinance

In relation to certain exhibitions therein named.

Sec. 1. Be it ordained by the City Council of Indianapolis, That from and after the passage of this Ordinance, and until the first day of Nov-meber next, it shall be unlawful for any person or persons to exhibit any Menagerie, or any Circus within the limits of said City.

- Sec. 2. The Treasurer of said city is hereby prohibited from receiving and giving a receipt for any money tendered to him, for a license for any such exhibition.
- Sec. 3. Any person or persons who shall exhibit any such Menagerie or circus within the limits of said city without a license therefor, signed by the President and Secretary of the City Council as required by section 23, of the Charter of said city, shall forfeit and pay for each day such exhibition shall continue any sum not less than One hundred dollars nor more than three hundred dollars, to be recarried in an action of debt before the Mayor of said City.
- Sec. 4. Any person or persons who shall permit any such exhibition on his, her, or their premises, without a license from the constituted authority of said city, shall forfeit and pay any sum not exceeding One hundred dollars, to be recarried in the manner aforesaid.
- Sec. 5. All ordinances, and parts of ordinances conflicting with the provisions of the above ordinance are hereby repealed.

Ordained and established this 16th day of July 1849, to take effect and be in force from and after its publication as required by the Charter.
