Indianapolis May 6th 1850

The Council Met, Present Messrs Cully, McQuat, Eckert, Rooker-Landis, Hetselgesson, & Mr. President.

The following Report from a select Committee, was read, accepted, and ordered to be spread upon the minutes.

The Committee to whom was refered the duty to examine the Condition of the Treasury, and to received from James H. Kenneday, late Treasurer, the Books, Papers, moneys and effects in his hands belonging to the City, respectfully Report.

That they have discharged the trust required of them, and find that the affairs of the treasury, as far as they are able to see from examinations of the several Funds, have been correctly managed: and that there is now in the Treasury the following sums of Money, or evidences of debt, towit,

All of which, together with statement of moneys collected on Delinquent list of April 1850, Treasurers Ledger, Certain Deeds, Bonds and other papers, have been handed over to the committee, and are herewith presented.

The Treasurer Elect presented his Bond which was approved of by the Council, and was sworn into office.

The committee appointed to enquire into the expediency of enlarging the

The Marshall Elect, presented his Bond which was Read and accepted by the Council.

A communication was presented, signed by G. W. More in reference to purchasing the fence around the Hospital Block, after the reading of which, on Motion, it was laid upon the table.

A communication signed by Charles Meikel, asking the consent of the Council to grant him the privilage of locating his Slaughter House on the River below the ford which crosses at the Grave Yard, was Read and on motion it was refered to a committee consisting of Messrs Hetselgesson, Rooker and Landis.

On motion of Mr McQuat the Council proceeded to the Election of a Market Master for the East Market House, Jacob Miller having Received 7 votes was declared duly Elected Market Master for said Market House for the term of one year and until his successor is elected and qualified.

On motion, the Council proceeded to the Election of a Market Master for the West Market, and on counting the Ballots, Jacob Miller having received 7 votes was declared duly Elected Market Master for said Market House for the term of one year, and until his successor is elected and qualified.

On Motion, the Council proceeded to the Election of Assessor. The names of Samuel P Daniels, David S. Beaty and William Johnson were presented as candidates for that office, on the first Ballot S. P. Daniels Received 3 votes, D. S. Beaty, 3 votes, and Wm. Johnson 1 vote, neither one of the Gentlemen having Received a majority of all the votes cast, The Council proceeded to a second Balloting, and on counting the votes it stood as follows, Samuel P. Daniels Received 4 votes, and David S. Beaty Received 3 votes, Samuel P. Daniels having Received a majority of all the votes cast was declared duly Elected Assessor for the City of Indianapolis for the present year.

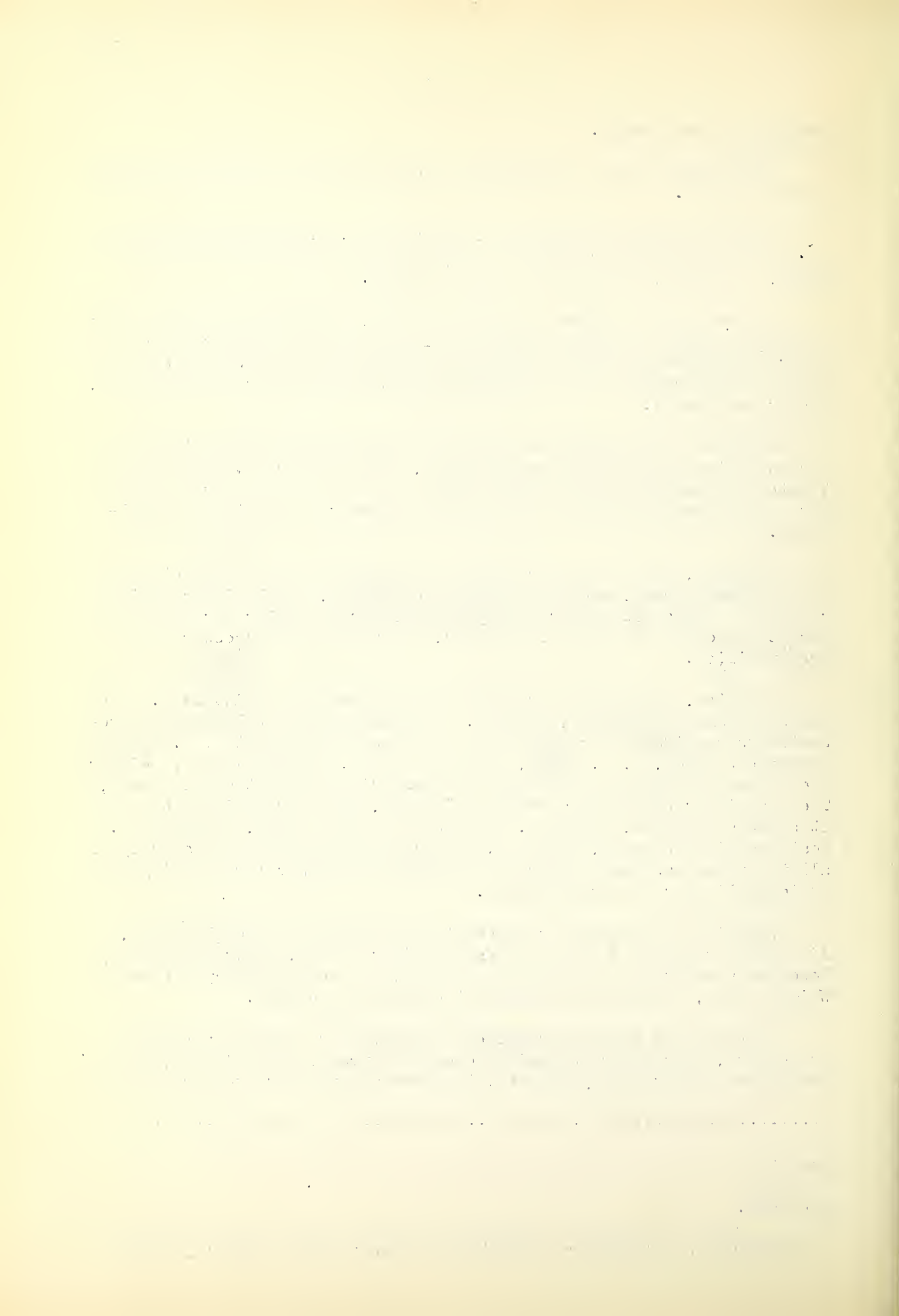
On Motion the Council proceeded to the Election of Weigh Master, Adam Haugh received 6 votes and Jacob Miller 1 vote, Adam Haugh having Received a majority of all the votes cast, was declared duly elected Weigh Master, to serve as such for the term of one year.

On Motion the Council proceeded to ballot for a Sexton upon the Grave Yard, George Laucks having Received 6 votes, Blank 1 vote, George Laucks was declared duly Elected, to serve as such for the term of

On Motion, a committee consisting of Messrs Cully, Eckert, McQuat

The Council Met. Present, Messrs McOuat, Cully, Eckert, Hetselgesson, Landis and Mr. President.

The following orders were then passed by the Council.

Ordered, That a committee be appointed to construct for the removal of the Bridge across the canal on Kentucky Avenue to Pogues Run in South Street and for the rebuilding of the same, and also to contract for for the removal of the Bridge on Delaware Street to New Jersey Street and rebuilding the same across Pogues Run, and also to remove on East Street to its proper place, and on Motion, Messrs Hetselgesson, Eckert & Landis were appointed said Committee in accordance with the provisions of the foregoing order.

On Motion the Council adjourned.
