An Ordinance

Amendatory of an Ordinance in relation to Theatres, Shows &c ordained the 7th of November 1851.

Sec 1. Be it ordained by the Common Council of Indianapolis, That the Sixth Section of an Ordinance entitled "An Ordinance in relation to Theatres, Shows &c ordained the 7th of November 1851 be amended as follows viz. "That the compensation to be paid for licenses, until otherwise ordered, shall be as follows. Ten dollars per day, or night for any theatrical performance within doors, thirty dollars per day or night for a circus or Menagerie, and five dollars per day or night during which any show, exhibition or performance, other than a theatrical performance, circus or Menagerie shall continue.

Sec 2. This Ordinance to be in force from and after its publication.



The following Ordinance - An Ordinance
To prohibit the feeding of horses within certain bounds in
the City of Indianapolis.

Sec 1. Be it ordained by the Common Council of the City of Indianapolis. That it shall hereafter be unlawful for any person to feed or cause to be fed any horse or horses, or oxen, on Meridian Street between Washington Street and Circle Street, or on Illinois Street between Washington Street and Market Street, or on Pennsylvania Street between Washington and Market Streets; and any person offending against the provisions of this Ordinance, upon conviction thereof before the Mayor, shall be fined in any sum not exceeding five dollars.



Sec 2. This Ordinance shall be in force from and after its publication, was ordained by the following vote





A petition was received from property holders on Illinois Street asking the Council to have the gutters on said street cleaned out. Mr. Maguire offered a preamble resolution for adoption, upon the reading of which, Mr. Karns moved to amend by inserting "and all graded Streets where gutters were made" upon the reading of which amendment Mr. Seibert moved to amend by adding the words "crossing Washington Street. Which motions did not prevail. And the following original preamble resolution.

Whereas in consequence of the manner in which our Streets are graded a very large amount of drainage is thrown on Illinois Street, which having but little fall, passes the water slowly even when unobstructed; and whereas the collection of filth and mud at this season of the year, in so central a portion of the City, may be extensively prejudicial to health, therefore

Resolved, That the Street Commissioner be required to cause the gutters on Illinois Street where mud and water collect, to be cleaned out at least once a month during the Summer months, and that as often as may be necessary to promote the drainage of the water through the said gutters, he cause such obstructions as may be thrown upon them by the natural wash to be removed at the expense of the City, and Such as may be placed there by individuals at the expense of



the individuals causing them.


On motion said resolution was Laid on the table.

That the Market Master put up posts at the end of the Market Houses to protect the pavements. Which motion prevailed.

Mr. Dunlap moved 330. That for his services in detecting incendiaries, John Wilson be paid the sum of fifty dollars, the amount of the reward which the Mayor was heretofore authorized to offer for such purpose. Which motion prevailed.

The Civil Engineer reported to the Council that he advertised for proposals to grade and gravel the side walk on North side of Maryland Street between Tennesse and Mississipi Streets and to gravel the ground around the East Market house, and to extend the culvert across Washington Street at



Illinois Street accompanying the report were the following bids Robert Harbinson proposed to grade the side walk on North side of Maryland between Tennessee and Mississipi Streets for 25 cts per cubic yard, and to do the gravelling for 55 cts per cubic yard.

Mr. Jones moved

That the contract for grading and gravelling said Maryland Street be awarded to Robert Herbison. Which motion prevailed.

Robert Herbison also proposed to gravel the ground around the East Market House for 62 cents per yard.

Mr. Karns Moved

That the contract for gravelling around the East Market House be awarded to Robert Herbison. Which motion prevailed.

William Hamelin proposed to pave and gravel the gutter on Illinois Street on the following terms for paving with Vernon Stone per superficial foot, including gravel 17 cents and for excavating per superficial: foot

Constany Vanoney and Antch Lahman proposed to gravel and pave said gutter on the following terms, for grading the gutter 24 cents per yard, and for pawing 18 cents per foot.

Mr. Nelson moved that said bills be refered to the Civil Engineer with instructions to consult the property holders about the expense. Which motion prevailed.

The Civil Engineer reported an estimate of a stone culvert across Illinois Washington and Kentucky Streets to amount to the sum total of \$2,110.25

On motion the Council adjourned until half pas seven P M.



The following Ordinance

An Ordinance
To prohibit the erection of Wooden Buildings within certain boundaries in Indianapolis therein described.

- Sec 1. Be it ordained by the Common Council of the City of Indianapolis, That it shall not be lawful for any person or persons to erect or cause to be erected, on any lot or part of lot, lying between East Street and the Canal and Market Street and Maryland Street so far as Maryland Street extends, and afterwards between Market Street and the Alley South of Washington Street, any building, or addition to any building before erected (privies excepted) unless the outer walls thereof shall be composed entirely of brick or stone and mortar; and any person or persons who shall violate this Ordinance, shall, upon conviction thereof, be fined in any sum not exceeding fifty dollars nor less than ten dollars, and in the further sum of not exceeding twenty dollars for each and every day Such prohibited building as aforesaid shall be suffered to remain after conviction as aforesaid, and it shall be the duty of the Marshall to remove any building or addition to any building which may be erected contrary to the true intent and meaning of this Ordinance.
- Sec 2. Whenever hereafter any frame building heretofore erected within the limits aforesaid shall be removed, the same shall not be re-located within said limits, but shall be removed without the same, and the relocation of any frame building within the limits aforesaid, shall be punished in the same manner as the erection of a new building, and shall be removed in like manner.
- Sec 3. The Ordinance passed the 3d day of Movember 1851, entitled "An Ordinance to prohibit the erection of Wooden Buildings on Washington Street" and the Ordinance amendatory to the same passed the 5th day of September 1853, are hereby repealed. Provided however, that their repeal shall not affect any proceedings commenced under the authority of the said Ordinances.



The following Ordinance

An Ordinance

For the regulation of Omnibuses and other vehicles kept for hire, and to preserve the peace and good order at Rail Road Stations.

- Sec 1. Be it ordained by the Common Council of Indianapolis. That every owner of one or more Omnibuses, Hackney Coaches, Drays, Carts, Wagons, and all other vehicles kept for the transportation of passengers, freight and other articles to or from any Rail Road Depot within this City for hire or pay before the same are used, shall present to the Mayor a statement in writing, designating his or her name and residence, and the kind of vehicle intended to be used.
- Sec 2. That upon the receipt of such statement the Mayor shall register the same in a book to be kept for that purpose and keep such statement on file, and shall designate the number to be affixed to such vehicle, proceeding from Number one, and shall issue a certificate thereof to such owner.
- Sec 3. Each transfer of such vehicle and each change of residence of the owner, within two days thereafter, shall be notified in writing to the Mayor who shall register the same in the book named in Section two, and keep said notice on file and issue a certificate thereof to the owner.
- Sec 4. The owner of every vehicle embraced in this Ordinance shall forthwith cause the number designated by the Mayor to be affixed and preserved in plain and prominent figures on a conspicuous part of such vehicle.
- Sec 5. That the Mayor shall receive from such owner twenty five cents for each certificate and entry made in conformity with this Ordinance.
- Sec. 6. And for the purpose of preserving peace and good order, at the several rail road passenger stations in this City. It is further ordained that the officer exercising the power of a police officer at the Union Depot under the appointment or Sanction of the Common Council, or in his absence, the City Marshall or his deputy shall have, and he is hereby invested with authority to prescribe the place where each omnibus or other carriage engaged in carrying passengers




to or from said depot, shall be located, while running thereat! to keep the streets bordering thereon, open sufficiently for the passage of persons and carriages, and the driver of every such omnibus or other carriage shall conform to the directions of such officer in the particulars aforesaid, and the powers herein conferred upon said officer, are conferred upon the superintendant of each Railroad passenger Station in this City at which no police officer of the City is present.

- Sec 7. Any person who shall violate any regulation herein ordained, shall be fined on conviction thereof before the Mayor, in any sum not less than five dollars nor more than thirty dollars.
- Sec 8. It shall be unlawful for any person at any rail-road passenger station in this City, at a time when passengers are arriving or departing therefrom, to use towards any other person or persons, any angry, abusive or threatning language, or to utter in the hearing of any other persons, any loud or filthy words of discourse and any person offending against the provisions of this Section shall on conviction thereof be fined in any sum not exceeding twenty dollars.
- Sec 9. It shall be unlawful for any person engaged in transporting passengers for hire, within this City in any vehicle embraced in this Ordinance to demand or receive as compensation therefor, more than twenty five cents for each passenger, with usual kind of baggage, not exceeding 100 pounds to any part of the City and any person offending against the provisions of this Section, shall on conviction thereof, be fined ten fold the amount of the excess so demanded or received.
- Sec. 10. The City Marshall and all other officers of the City police shall arrest with or without process and bring before the Mayor all persons who, in their presence, shall violate any of the provisions of this Ordinance.
- Sec 11. The Ordinance on this subject passed the 6th of March 1854, is hereby repealed, and the amount collected for license under that Ordinance, except 25 cents in case which shall be retained for giving the Certificate, shall stand to the credit of the individuals from whom it was collected, to be applied to the payment of their taxes.
- Sec 12. This Ordinance shall be in force from and after its passage
