Pier and Hand rails to be good mortice and tennon work, properly pinned. Flooring 12 inches broad, and 3 inches thick. Strips on centre and sides of bridge 5 & 3 inches. The flooring to be properly spiked down to the Stringers, with Six inch spikes. The lumber used in the construction of the Bridge to be the best quality of White Oak timber free from Sap, Shakes, and other defects. So much of the lumber of the old Bridge to be used in constructing abutments and for boarding up the ends of the New Bridge, and the balance of the lumber to be laid aside for the use of the City. 

To the President and Members of the City Council
I would recommend to you, to have pumps placed at the



Cisterns; one at the crossing of Meridian Street and Ohio, as the pump is of no account as it is at present, and the Cistern at the same place is not in order, owing to a crack, Six feet below the cap. I would recommend to this body, to investigate the Bonds of the Contractors or builders of the Cistern as there has been some delay in finishing the cisterns now under contract. I would also recommend a pump at the Third Ward School house on New York Street, the pump being made useless by throwing gravel in the spout (by boys). The Cistern on South Street at the Depot is short of one cap. All the rest finished are in good order. The O K Bucket Company have reorganized. I would recommend the Company to your consideration as they have been an efficient company heretofore. They are of advantage to that part of the City, where fire cannot be reached by water from the Cisterns now in use This Company are in want of New Buckets. I would recommend you to furnish them, if it meets with your approbation, and also a proper room to hold their meetings


