Specification.

The Bridge to be 68 feet long and 28 feet wide. The dimensions of lumber are marked on the plan. Pier and hand Rails to be good mortice and tennon work properly pinned. Flooring 12 inches broad, and 3 inches thick. Strips on centre and sides 5 & 3 inches. The flooring to be properly spiked down to the stringers with six inch spikes. Lumber used in the construction of the bridge to be the best quality of white oak timber free from shakes, sap and other defects. All the work to be performed in a substantial workman like manner to the satisfaction of the Civil Engineer, and finished on or before the 1st day of November 1854. An Ordinance to establish a police force in the City of Indianapolis, and prescribing its duties

- Sec 1 Be it ordained by the Common Council of the City of Indianapolis, that there shall be, and hereby is established, in said City, a police force, to consist for the present, of two watchmen in each ward of said City who shall be under the direction of a cheif or Superintendent
- Sec 2 Said watchmen shall be elected by the Common Council of said City annually, at the time set apart for the election of other officers elected by said Council subsequent to the first Tuesday in May of each year; provided, that the persons already elected shall continue as such until the next annual election, and said Council shall, at any time, select persons to fill any vacansies which may occur in said watch; and said watchmen shall, before entering upon the discharge of their duties, each take an oath before the Mayor or other officer qualified to administer oaths, to support the constitution of the United States, the Constitution of the State of Indiana, and faithfully to discharge the duties of a watchman of said City, while serving as such
- Sec 3 Said watchmen shall each receive for their services the sum of per day, and in addition thereto the fees which the Marshall would otherwise be entitled to, in all cases of arrests made by them, when the party arrested is convicted
- Sec 4 The Marshall of said City shall be chief of said watch, and it shall be his duty to see that they discharge their duties properly, and to have the general superintendance over them, and to report any delinquencies to the said Council
- Sec 5 The hours of service of said watch shall be from O'clock of each evening until of the next morning, and each of such periods shall constitute one day
- Sec 6 The watchmen elected for each ward shall perform service in their respective wards, and shall not, unless in a case of emergency, or when directed by the chief of said watch, go beyond the bounds of their respective wards
- Sec 7 It shall be, and it is hereby made the duty of said watchmen, during the hours of their service, to keep strict watch within the bounds of their respective wards, and to observe the conduct and movements of all suspicious persons, to suppress all riots, disturbances, and unlawful assemblages, and to arrest without process and bring before



the Mayor or commit to Jail until the next morning, when they shall be brought before the Mayor for trial, any and all persons discovered or caught in the act of violating any of the Ordinances of said City, or of the State of Indiana, or in the commission of any unlawful act, and all persons concerned therein

Sec 8 No watchmen, or any person engaged in said watch, shall be bail for any person arrested by any officer, for any offense, or for any reason, either for appearance at court, or for any other purpose

Sec 9 If any of said watchmen shall neglect their duty, or be absent at any time; without a valid excuse, such watchman may be removed from said watch by said Council, and in case of the absence of any of said watch, it shall be the duty of the chief of said watch, if he deems it necessary, to employ a fit person to fill the place of such absentee, until such absentee returns or a successor is elected and qualified, for which service such person shall be entitled to the same pay

Sec 10 No watchman shall be entitled to an allowance for services until he produces to the Council a certificate from the chief of said watch, stating the amount of service rendered by him




Sec 3 Said watchmen shall each receive for their services the sum of one dollar and fifty cents per day

Sec 4 The Council shall elect one of said watchmen as captain of said watch, to serve for the present year, or until his successor is elected and qualified, and it shall be his duty to see that the watchmen discharge their duties properly, to have the general Superintendance over them; and to report any delinquencies to the said Council

Sec 5 The hours of service of said watch shall be from nine o'clock of each evening until five O'clock of the next morning, and each of such periods shall constitute one day

Sec 6 The watchmen elected for each ward shall perform service in their respective wards, and shall not, unless in a case of emergency, or when directed by the Captain of said watch, go beyond the bounds of their respective wards

Sec 7 It shall be, and it is hereby made the duty of said watchmen, during the hours of their service, to keep strict watch within the bounds of their respective wards, and to observe the conduct and movements of all suspicious persons, to suppress all riots, disturbances, and unlawful assemblages; and to arrest without process and bring before



the Mayor, or commit to Jail until the next morning, when they shall be brought, before the Mayor for trial, except the day following should be Sunday in which case they shall be brought before the Mayor on the Monday following, any and all persons discovered or caught in the act of violating any of the ordinances of said City, or laws of the State of Indiana, or in the commission of any unlawful act, and all persons concerned therein

Sec 8 No watchman, or any person engaged in said watch, shall be bail for any person arrested by him or said watch, for any offense, or for any reason, either for appearance at Court, or for any other purpose

Sec 9 If any of said watchman shall neglect their duty, or be absent at any time, without a valid excuse, such watchman may be removed from said watch by said Council; and in case of the absence of any of said watch, it shall be the duty of the Captain of said watch, if he deems it necessary, to employ a fit person to fill the place of such absentee, until such absentee returns or a successor is elected and qualified, for which service such person shall be entitled to the same pay

Sec 10 No watchman shall be entitled to an allowance for services until he produces to the Council a certificate from the Captain of said watch, stating the amount of service rendered by him, which certificate shall be returned to the Council the first meeting of each month

Sec 11 This Ordinance shall be in force from and after its passage



The following communication was received

To the City Council of Indianapolis Gentlemen As the Agent representing the owner of the 'grave yard pond' I protest against the action of your Council ordering the drainage of the same at the expense of the owners, until the City, shall first perform her portion of the same, by making the proper improvement on Kentucky Avenue, through said pond to the River for the accommodations of the Citizens Until this (Kentucky) Avenue is properly graded so that the public shall be accommodated in that portion of the City by having the proper access to the River, little or no value can attach to the ownership of said pond, and the expense of such drainage would be onerous and vexacious to the owners of said property - It is the opinion of the owners of said property that said pond cannot be drained but will have to be filled up in a great measure, and that therefore any expense incurred by drainage will be wholly lost to the owners, and it should not be done. When said Avenue is made through said pond to the River, as the interest of the Citizens requires it shall be, a large part of the present pond will be damed up North of the Street or Avenue, and cannot be drained in any other manner than by filling up; and that portion of said pond, South of the Street, or Avenue, is at the present time deeper than the bed of the river so that in fact it will have to be filled up also in order to drain it; and every attempt to drainage by ditching will be so much labor lost, and money entirely thrown away. The undersigned therefore in behalf of the owners of said property respectfully respectfully asks the Council to review their proceedings in relation to the drainage of said pond, and suspend all action in relation thereto, until they, the City Council at least shall have made the Avenue through the same a good and proper road for the accommodation of the Citzens, and until said property shall be divided amongst the heirs John S Eckert


