GENTLEMEN: On the 23d of February, 1898, the Town of Irvington entered into a contract with myself for the improvement of Washington street in Irvington, from Central avenue to Wallace street. This improvement was constructed and pursuant to the contract the town reserved, of the amount coming to me for street and alley crossings in said town, as a guaranty fund pursuant to said contract for a period of seven years, the sum of \$2,364.10, which sum was to bear interest in my favor at the rate of 5% per annum.

The work was accepted April 26, 1899, and the guaranty period expires April 26, 1906.

This obligation now rests upon the City of Indianapolis and there will be due and payable to me on April 26, 1906, the \$2,364.10 above named together with interest since April 26, 1901, amounting to \$591.02, making a total of \$2,955.12.

GENTLEMEN: Before paying Mr. W. C. Smith for the work he has done on Washington street, from Wallace street to Central avenue, I would re-spectfully recommend that your Board order him to make repairs on this street, between the above mentioned points, as follows:

Replace the marginal stones on both sides of the street railway tracks in front of Hilton U. Brown's residence; also about 700 brick at this point, just east of Pleasant Run. Replace marginal stones on both sides of the street railway tracks about 70 feet west of Ritter avenue.

At a point 100 feet west of Central avenue next to the curbing the bricks have sunken, and they have also sunken at a point a little farther west. At this latter place there are two holes in the street which need repairing. West of Pleasant Run for about 200 feet the marginal stones on both sides of the street railway tracks are missing and will have to be replaced.

At Spencer avenue two feet of the curbing on each side of the avenue is broken. Fourteen feet of curbing is broken at Butler street. At Irvington avenue eighteen feet of curbing on both sides of the street is broken. At Ritter avenue twenty feet of curbing broken. At Thompson avenue six feet of curbing broken. At Central avenue four feet of curbing broken. At Layman avenue fourteen feet of curbing broken. At Whittier avenue six feet of curbing broken. At DeQuincy avenue ten feet of curbing broken; also eight feet a little east of this point.
