REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE
CITY OF INDIANAPOLIS,
MONDAY, OCTOBER 8TH, 1866, 7 O'CLOCK, P. M. }

The Common Council met in regular session.

Present—His Honor, the Mayor, John Caven, in the chair, and the following members :

Councilmen Emerson, Fletcher, Glazier, Grosvenor, Jameson, Kappes, Loomis, McNabb, Seidensticker and Staub—10.

Absent—Councilmen Allen, Brown, Coburn, Colley, Kemker, MacArthur, Schmidt, and Thompson—8.

The proceedings of the regular session held October 1st, 1866, were read and approved.

Mr. Fletcher offered the following resolution :

Resolved, That the Mayor and Chief of Police be directed to appoint such extra Police as they may deem best for the purpose of maintaining order during the election on the 9th instant.

Which was adopted.

On motion by Mr. Grosvenor,

The Marshal was instructed to shoot the tame pigeons from the buildings in the vicinity of the Theatre.

On motion by Mr. McNabb,

The City Engineer was directed to change the grade of the sidewalk on Henry street in front of Frank Donley's house, so the grade will not damage the same.

Mr. Seidensticker offered the following resolution:

Resolved, That His Honor, the Mayor, be requested to issue his Proclamation instructing the Police to strictly enforce the law against the sale of intoxicating liquors on the day of the General Election for 1866, and that the saloons around the Court House Square be especially requested to keep their establishments shut on that day.

Which was adopted.

Dr. Jameson, from the Committee on Printing and Stationery, made the following report:

INDIANAPOLIS, Oct. 8, 1866.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:—The Committee on Printing and Stationery beg leave to report an ordinance making appropriations for the payment of the City Printer, as per accompanying bills and vouchers, and recommend the passage of the same.

Your Committee are of the opinion that stationery can be purchased much cheaper for cash, and would respectfully recommend that City Warrants be issued to the Committee for the purchase of the same, and that said warrants be sold for cash, and that the proceeds be applied, from time to time, to the purchase of such collections of stationery as may be needed, and a full report made to your honorable body quarterly.
