Mr. Craft, from the Committee on Contracts, made the following majority report:

INDIANAPOLIS, January 2, 1872.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN—Your Committee on Contracts, to whom was referred sundry proposals for the improvement of streets, have examined the same, and find the following name: persons to be the lowest and best bidders, and would recommend that contracts be awarded accordingly:

FIRST.

For grading and bowldering East street, from South street to Coburn street, to George W. Buchanan, at one dollar and five cents per lineal foot, on each side of the line improved.

SECOND.

For curbing the outside edges of the sidewalks with stone, on East street, from South street to Coburn street, to George W. Buchanan, at fifty-three cents per lineal foot front on each side of the line improved.

THIRD.

For grading and paving with brick the sidewalks on East street, from South street to Coburn street, to George W. Buchanan, at fortyeight and one-half cents per lineal foot front on each side of the line improved.

FOURTH.

For grading and graveling Wabash street, from Missouri street to West street, to James Mahoney, at thirty-five cents per lineal foot front on each side of the line improved.

EIFTH.

For boxing and planting shade trees on Broadway street, from Christian avenue to Forest Home avenue, to Bernard Hamil, at two dollars and forty-five cents per tree, and box included.

Under the present charter the entire Force is elected annually by the Board of Police, consisting of his Honor the Mayor, as Secretary, Mr. Marsee, as President, Messrs. Woodburn and Wiles as members, and confirmed by the action of the Common Council.

As the Board who has the appointing of the Police Force are themselves elected annually, it follows that the tenure by which the Police hold their office is slight and uncertain.

Under the present system it might happen that a complete change would be made in the entire force every year, and that men who have been appointed one year, and gave evidence of possessing many of the requisites of a good Policemen, may at the succeeding election find themselves left out, not for any neglect of duty or incompetancy, but simply because of change of Board and Council; and new and inexperienced men may be appointed, who must in turn be taught and disciplined, only to graduate at the end of twelve months, and thus impairing the efficiency of Force in no small degree.

For these and other reasons, and because it takes time and experience to make an efficient and reliable Police Force, I believe it would be far better for the city at large that the Force should be selected with great care as regards their character and habits, and peculiar qualifications for the duty expected of them, they should hold office for a term of years or during good behavior, of course to be discharged for incompetency or misdemeanor, and neglect ef duty.

All care should be taken in the selection of men to compose a Police Force, and the tenure of office vested on more substantial foundation than the uncertain result of an annual popular election. And if the salaries were fixed at such figures that good, honest, sober, reliable and faithful men could accept the position, we would soon have a Police Force that would not only be a credit to our city, but a guarantee to every citizen that the laws would strictly be enforced, crime detected and punished, and proper protection aforded to all classes of community.

[Adjourned Session

I do not think that any set of men can be made to take the same interest which is expected of them, or who will act without fear or favor in the performance of duty, while they are elected for one year only, and so little interest taken in their welfare by the citizens. More encouragement should be given, for it would add to the efficiency of the Force.

STRENGTH OF FORCE.

The Force at paesent consists of one Chief, at a salary of fifteen hundred dollars per annum, and two Lieutenants, at a salary of ten hundred and ninety-five dollars per annum; one Sargent, at a salary of eighty-five dollars per month; twenty-two night Patrolmen, at salaries of seventy-five dollars per month, and eleven day Patrolmen at same salaries; one Turnkey, making a total of thirty-eight members all told.

I would respectfully recommend to your honorable body the propriety of dividing the city into two Police districts, having Washinton street for the dividing line, having a North district and a South disirict, and the creation two more offices, that of Sargent to report the action of Patrolmen to the Lieutenant stationed on line Washington street, as I deem it impossible for one officer to look over the amount of territory within the city limits, and do justice to himself and city.

AREA OF CITY, STREETS AND ALLEDS.

The city of Indianapolis contains within its corporate limits an area of about twelve square miles of territory, with one hundred and fifty-eight miles of street, and about one hundred and fifty miles of alley, besides the open comons, with a population of about fifty-five thousand souls. With the force as at present organized, we can only place twenty-four men on duty at one time. Each man has, on an average, of one half square mile of territory to supervise, with six and one-fourth miles of street, and the same amount of alley to patrol, and twenty-two hundred and ninety-two inhabitants to protect and control, to say nothing of the value of property lying within the limits of his beat, which he is to guard against burglars and fire.

INCREASE RECOMMENDED.

Our city is steadily increasing in population, and wealth, and importance. With the new additions to the west of the river it will become necessory to extend to the citizens of that section some protection; I would, therefore, recommend to your honorable body the propriety of appointing a sufficient number of men to patrol that

section lying west of White River, and let it be styled as the twelfth Police District.

I would also recommend a reorganization of the force on the following basis: One Chief, two Lieutenants, three Sergeants, one Turnkey, twenty-four Night Patrolmen, twelve Day Patrolmen, which will make a force of forty-three men, all told.

There has been lodgings furnished at the Station House, for six months ending December 31st, to 280 paupers, and 324 meals furnished to the same, the majority of whom were importations from other cities.
