(a) A loading zone beginning at a point seven (7) feet west of the first alley west of South Illinois Street and extending west a distance of twenty-five (25) feet on the north side of West Maryland Street, for the use and occupancy of the Stuart Moving and Storage, Inc., No. 114-116 West Maryland Street.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor and compliance with all laws pertaining thereto.

Sick Leave of Members of Fire Department. - Any active member of the Indianapolis Fire Department who shall suffer accident or injury while in line of duty or who shall suffer illness and be thereby rendered unable to perform the duties of his employment as certified by the Indianapolis Fire Department Surgeon, shall be entitled to ninety (90) days sick leave with full pay or for the period of such incapacity, should the same be of less than ninety (90) days.

Any such active member remaining incapacitated for more than ninety (90) days may be compensated at the discretion of the Board of Safety.

3-1002. Annual Leave. - Each active member of the Indianapolis Fire Department shall receive hereafter not less than fifteen (15) consecutive days annual leave with full salary each and every calendar year. Provided: that hereafter any active member of said Fire Department who shall have served not less than ten (10) years as a member of such department shall receive not less than twenty-one (21) consecutive days vacation with. full salary each and every calendar year.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

I move that you appoint a committee of three to investigate this situation and to report to the Council what measures will be necessary to correct this condition.

Mr. Radel made a motion that the President appoint a committee of three to investigate our Municipal Code of 1951 which regulates the operation and licensing of taxicabs in the City of Indianapolis. The committee to report back to the Council at some future date with recommendations to strengthen our present Municipal Code to eliminate the common abuses practiced in the taxicab industry and which our present taxicab code does not have enough enforcement provisions.
