All of Lots Nos. 18, 19 and 20 in Woolings Gold Coast Addition, 2nd Section, an addition to the City of Indianapolis, Indiana, as recorded in Plat Book 25, pages 45 to 48, in the office of the Recorder of Marion County, Indiana; also all of Lots Nos. 104, 105, 106 and 107 in Woolings Gold Coast Addition, an addition to the City of Indianapolis, Indiana, as recorded in Plat Book 24, Page 534 in the office of the Recorder of Marion County, Indiana.




